





Nandipur Power Project is a 425 MW combined cycle thermal power plant situated at Nandipur near Gujranwala in the Punjab province of Pakistan. Being constructed by the China Dongfang Electric Corporation, the project was completed in March 2015.

In January 2008, Pakistan Electric Power Company (PEPCO) signed a Rs. 23 billion (\$329 million) contract with Dong Fang Electric Corporation of China to construct the Nandipur Power Project and paid it a 10 per cent down payment. By mid-2010, much of the work at this power project was complete and it was expected be finished on schedule in April 2011.

However, the project suffered delays as the summary, sent by the Ministry of Water and Power for legal opinion of the Ministry of Law & Justice, remained pending with the latter for two years from March 2010 to March 2012. As a result, machinery worth \$85 million remained stuck at the Karachi Port for over two years.

Prime Minister Nawaz Sharif inaugurated the first turbine of the project on 31 May 2014.[13] But the plant remained operational for only five days after the inauguration and had to be shutdown due to mismanagement and use of inappropriate fuel.[14] Later in July 2015 it was reported that the plant was once again functional and producing the contractual output of 425MW.
